## Collection Minimums (Effective 4.6.20)

### ❖ *Simplified requirements for collection*

<b><u>Poly Drum Only:</u></b>	<b><u>IBC Only:</u></b>	<b><u>Mixed Shipment: IBC and Poly Drum</u></b>
<ul style="list-style-type: none"> <li>• Poly Drum Minimum: 100 or more serviceable drums are required for free collection</li> </ul>	<ul style="list-style-type: none"> <li>• IBC Minimum: 10 or more serviceable IBCs are required for free collection</li> </ul>	<ul style="list-style-type: none"> <li>• Mixed shipments require a minimum of 10 IBCs or 100 poly drums for free collection</li> </ul>

Shipments below the minimums will still be received at MPS facilities, but will require the customer to arrange freight. MPS will assist in providing arrangement number and handoff to preferred logistics providers. Poly drum recycling fees will still apply.

## Poly Drum Recycling Fees (Effective 6.1.20)

<ul style="list-style-type: none"> <li>• No change to the value of reconditionable used plastic drums received by MPS</li> <li>• \$5 charge will be assessed for all non-reconditionable used plastic drums received by MPS</li> <li>• Charge to be paid by PO</li> </ul>	<ul style="list-style-type: none"> <li>• \$10 charge will be assessed for all used plastic drums received by MPS</li> <li>• Charge to be paid up front before pickup by credit card</li> </ul>

Shipment of heavy containers (not RCRA empty) or other junk material will require customer to coordinate removal from MPS facility at their cost. Repeated offenses will result in a requirement for a payment method to be kept on file or potential refusal of collection.
