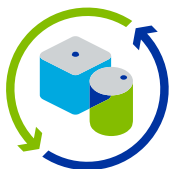

It All Starts With Recover Syst-M

Recover Syst-M is the first step in responsibly extending the life cycle of packaging. By returning your empty IBCs and drums, your company is diverting waste from landfills, reducing your carbon footprint, and supporting the circular economy. **Here's how the process works:**

1 | Collection

Empty packaging collection is scheduled through our website, by email, or by phone (soon, you'll be able to use our mobile app!). Within days, empty packaging is picked up and transported to one of our local facilities.

2 | Reconditioning

Returned IBCs are assessed and either washed or rebottled. Rebottled IBCs use the existing steel cage in combination with a new bottle and components. Returned drums are cleaned, and the components are replaced.

3 | Reuse

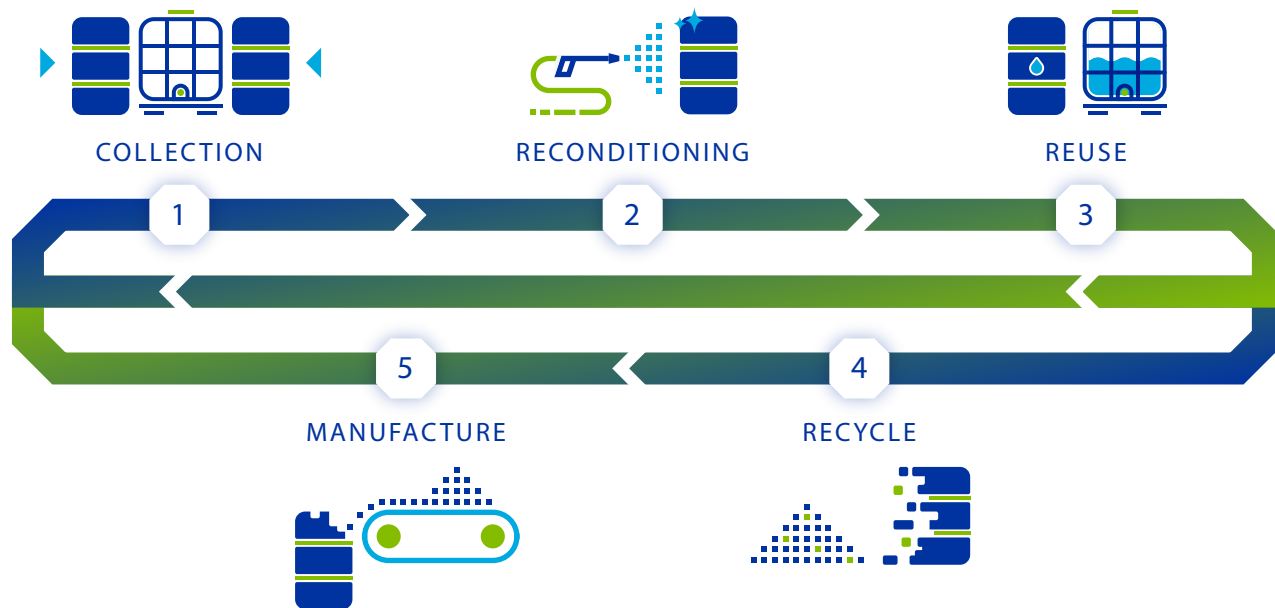
Reconditioned IBCs and drums are subjected to vigorous testing to meet the highest safety standards before being reintroduced to the market. In 2019 alone, our reconditioning and reuse program helped customers avoid over 1.5 million metric tons of carbon emissions.

4 | Recycle

Once an IBC or plastic drum has reached the end of its usable life, it's collected and transported to one of our recycling facilities. Our specialized recycling processes transform the packaging into high-quality Post-Consumer Resin (PCR) that we call Recolene.

5 | Manufacture

Recolene is used to produce our Infinity Series of products as well as other product components. The Infinity Series is the most comprehensive portfolio of UN-certified products made from recycled resin - completely generated in-house at Mauser Packaging Solutions.



This closed loop system gives packaging new life, while reducing our mutual environmental footprints.

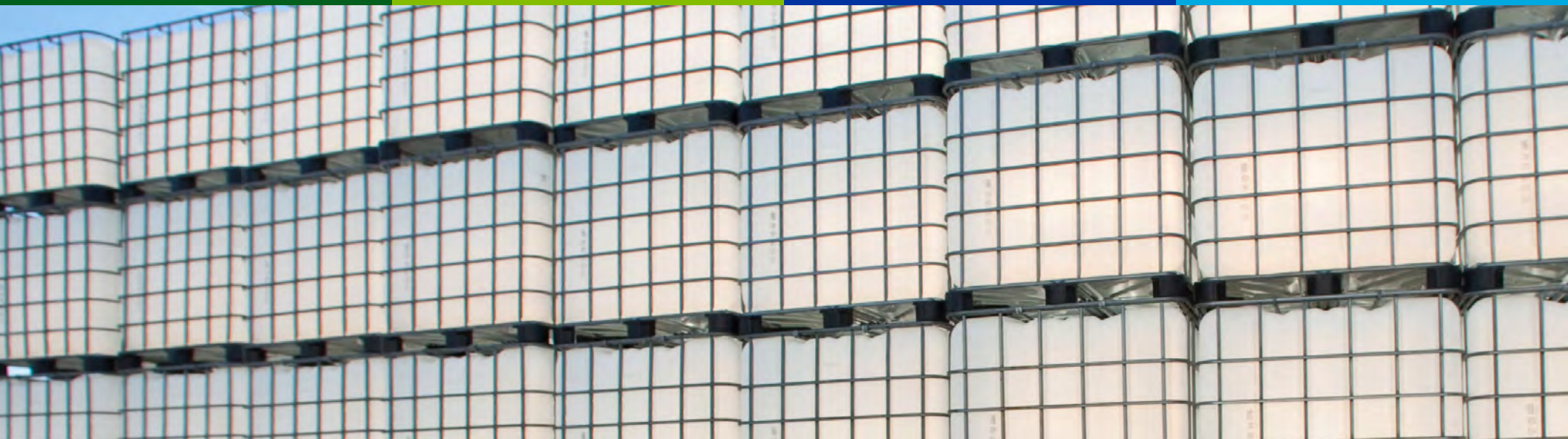
Duties of the Emptier

- ▶ The number of containers and the GHS classification must be communicated with each pick-up request. Safety Data Sheets must be made available for the carrier, and the recipient, and be submitted upon request.
- ▶ The emptier issues all necessary documentation for the transport required by local legislation.
- ▶ It is the duty of the emptier to make sure that all containers are empty and prepared for shipment in accordance with local regulatory requirements.

Restrictions

Mauser Packaging Solutions is authorized to:

- ▶ Refuse the pick-up of non-conforming containers or return non-conforming containers to the sender at their expense.
- ▶ Charge incremental freight expenses for pick-ups where the number of conforming containers does not match the original request.
- ▶ Charge for containers that cannot be reconditioned for reuse.
- ▶ Charge for the return of certain IBCs that are unsuitable for reuse and must be cleaned, destroyed, and recycled.



General Terms and Conditions

Recover Syst-M is a quick and easy way to return your empty IBCs and plastic and steel drums for reconditioning. As safety and compliance with local regulatory laws is our priority, collected packaging must comply with the guidelines below. Country specific terms and conditions will be provided once a pick-up request is submitted.

Conditions for Removal of Empty Packaging

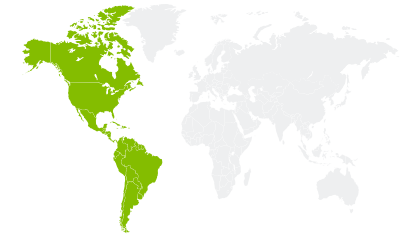
- ▶ Containers must be **empty of residue** and **prepared for shipping** in accordance with regulations as per countries of origin, transit and receipt.
- ▶ All openings are **sealed completely** tight with **original lid, original drainage tap,** and **original sealing caps;** as if the container was being shipped full of product;
- ▶ Containers are **free of external contamination;**
- ▶ IBCs are in reusable condition and **free of damage to the cage and pallet** (e.g. deformation and oxidation which could compromise reuse or transport);
- ▶ The last filling good is **clearly marked** and the marking **complies with the applicable traffic regulations;**
- ▶ **Label plate, filling good labels,** and **dangerous good labels** are **clearly identifiable;** the UN markings are **embossed** or **printed;** with **valid design type approval** in case of dangerous goods;
- ▶ If the last filling good was **toxic, flammable, carcinogenic, mutagenic, excessively hazardous** or **strong-smelling,** the package must be **decontaminated and clearly labeled as "NEUTRALIZED"** or triple-rinsed as mandated by local regulatory agencies,
- ▶ The containers were **not** filled with any product **other than that stated.**



Should a package fail to meet one of the collection conditions outlined, Mauser Packaging Solutions is entitled to refuse to accept the container and/ or subsequently charge the end user the cost to return the package.
