- 7) No product other than indicated had been filled into the ibc

Drivers will be granted access to the collection point, so that observation of the loading activities is possible. Please be aware that the packaging cannot be assessed by the driver.

All IBCs will be assessed by qualified personnel by entry at NCG location. In case that the quantity announced is different to the quantity of packaging ready for collection, packaging do not meet the conditions set out above or if disposal is required according to the assessment marks (toxic, flammable, carcinogenic, mutagenic or exessively hazardous or smelling), NCG reserves right to:

- 1) reject the collection
- charge disposal costs for professional disposal of unusable packaging or residues to the customer
- 3) charge incremental freight expenses for pickups where the number of IBCs does not match the number in the request.

The collection occurs on the basis of the General Terms and Conditions of Service for Products and Services of National Container Group in Germany in the version 2017.1 as at 23.01.2017 (www.mauserpackaging.com). With signature the customer confirms that he has read and explicitly accepts the content.
