Collection Minimums (Updated March 1, 2023)

Drums Only
 • 100* or more serviceable drums are required for collection

IBCs Only
 • 10* or more serviceable IBCs are required for collection

Mixed Shipments (IBCs & Drums)
 • Requires a combined minimum equivalent of 25 "pallet squares" of IBCs and drums* (example: 8 IBCs and two pallets of four drums each)

*Mauser reserves the right to request a higher unit minimum for certain geographic areas.

All shipments must comply with Mauser's Container Acceptance Policy (CAP) requirements. [Current version available HERE.](#)

With prior approval, Mauser facilities may accept shipments below stated minimums providing the shipper arranges and pre-pays the freight. Mauser will assist with providing an arrangement number for receipt of goods received.
